Minutes of the Meeting of Northrepps Parish Council held on 02 February 2016 at 7.00 pm at Northrepps Village Hall

Minutes of the Parish Council Meeting held on 05 January 2016
 It was AGREED that the minutes of the Parish Council meeting held on 05 January 2016 be APPROVED as a true record. The minutes were signed by the Chairman.

2. Apologies for absence

Apologies were accepted from Cllr. Bumphrey (work), Cllr. Claxton (work), Cllr. Callaghan (family illness), Cllr. Riggott (meeting elsewhere). Apologies were noted from District Cllr. Fitch Tillett and PCSO Holmes.

3. Declarations of Interest & Dispensations in respect of Disclosable Pecuniary Interests

Cllr. Mackay declared a DPI in planning application PF/15/1902 due to family connections.

The Clerk advised that she was obtaining clarification as to whether members still need to request a dispensation in respect of budget and precept matters and in the meantime recommends that members request a dispensation to be considered at the next meeting.

4. Public Participation

Concern was raised in respect of off road motorcycles being ridden at speed along FP07 and FP10. The police are aware. A meeting has been arranged with Norfolk Trails Officer Andy Williams at which the removal of the stile will also be discussed. It was agreed that the Chairman of the Parish Council will attend the meeting. Also refer minute item 9.1.

A representative from the Friends of the School asked whether the Parish Council could provide a grant towards the cost of holding the village fete on 29 May 2016. The Clerk advised that there were restrictions in respect of giving grants to schools but would make enquiries. It was suggested that the Parish Council consider sponsoring one of the attractions at the fete. The Friends of the School will provide a list.

5. Casual Vacancy

It was **AGREED** to co-opt Mr Guy Bartlett on to the council.

6. Police

The police report was read out (refer attached).

7. District Council and County Council

7.1 District Councillor Report

In the absence of Cllr. Fitch Tillett, Cllr. Northam provided an update. "We are endeavouring to provide a balanced budget for 2016/17 without increasing Council Tax. The Council and Eastlaw, our excellent Legal Team, have won national awards for the excellence of works done. To increase income to the Council, office space has been leased to the County Children's Services and also the Department of Works and Pensions".

7.2 County Councillor Report

"The Govt grant for the 2016/17 budget year has been reduced by £28,733 million. The Budget consultation provided 3101 responses, a record. Of the responses 77% agreed to increasing Council Tax. The Norfolk Fire and Rescue Service has an Urban Search and Rescue Team, one of only five in the UK. Over the Christmas period they were helping the flooding problems in Cumbria. The County Council Children's Outreach Service provided assistance and guidance to nine families over Christmas, this support ensured, most importantly, that no children from those homes were taken into care over Christmas".

Cllr. Northam left the meeting.

8. Planning

8.1 Planning Applications for consideration

Y/1/2015/1011 Provision of new 6th form accommodation, additional car parking and pedestrian footpath, and vision splay improvements to main entrance at Sidestrand Hall School – It was **AGREED** to support this application.

AN/15/1619 Display of 3 directional signs for Karttrak, Hall Road – It was **AGREED** to object if these signs are on highways land. Members would support an application for a brown tourist sign.

LA/15/1788 Installation of wood burning stove and associated flue at Dairy Barn, Winspur Barns, North Walsham Road – It was **AGREED** to raise no objections to this application.

Cllr. Mackay left the meeting for this item and Cllr. Fish took the Chair.

PF/15/1902 Change of use of farm buildings to 5 residential dwellings at land adjacent to North Norfolk Business Centre, Crossdale Street – It was **AGREED** to raise no objections to this application.

Cllr. Mackay rejoined the meeting and took the Chair.

Planning Decisions from NNDC/NCC:

There were no decisions to report.

8.2 Parish Plan and Neighbourhood Plan

It was noted that the Chairman and Clerk are yet to meet with representatives from Bodham.

8.3 Local Plan

Members were in receipt of the latest newsletter and the call for sites. It was **AGREED** to suggest that the site immediately to the north of Broadgate Close be considered.

8.4 Other Planning Matters (for information only)

There were no other planning matters to report.

9. Highways & Transportation

9.1 FP10 Removal of Stile

Members were in receipt of copies of correspondence from residents and members of the PCC raising concern at the removal of the stile by members of the Norfolk Trails Team. An email from the Trails department was read out and the contents noted. Members voiced concern at the lack of communication with either the Church or the PCC. It was felt that the stile was not in a dangerous condition. It was installed in the early 1980s to stop motorcyclists and horse riders from crossing the churchyard.

It was **AGREED** that the Chairman would attend the meeting with the Trails Officer (refer public participation above).

The Clerk was instructed to acknowledge the letters received.

9.2 Passing Places

Correspondence was read out and it was noted that the passing places have been constructed in accordance with the drawings submitted and that the conditions had been discharged by NNDC. Cllr. Fitch Tillett is writing to ask that the signage be removed. Members are still concerned about the stability of the banks and asked the Clerk to contact the developer for an update.

9.3 Trees & Hedges

It was noted that the landowners are dealing accordingly in respect of the overgrown trees and hedges.

9.4 **Parking**

There were no further issues to report.

9.5 **Highway Rangers**

It was noted that a list of issues have been passed to the Highway Rangers to deal with on their forthcoming visit including the cleaning of the road under the railway bridge. The Clerk was asked to contact Highways in respect of the recently filled pothole on Crossdale Street which already needs to be refilled.

9.6 Traffic Orders

Members were in receipt of the traffic orders for works on Norwich Road.

9.7 **To receive any other Highway Matters** (for information only)

It was noted that there had been confusion over the request to remove the Miramar Vets signs. Members confirmed their support for the removal of signage from highway land.

It was noted that Cllr. Callaghan had received a request from residents for some play equipment for toddlers at Christopher's Close. It was noted that the Parish Council do not have any land there and that all residents would need to be consulted. It was suggested that this could perhaps be considered for a future budget
